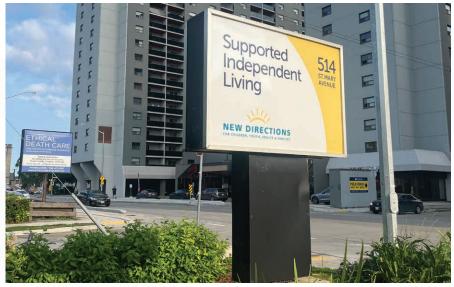

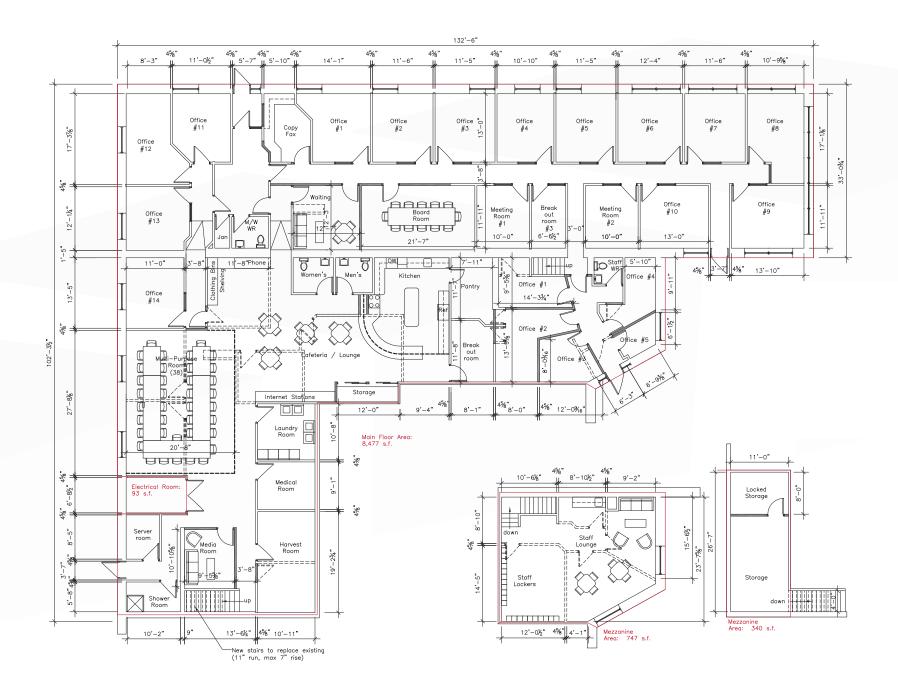

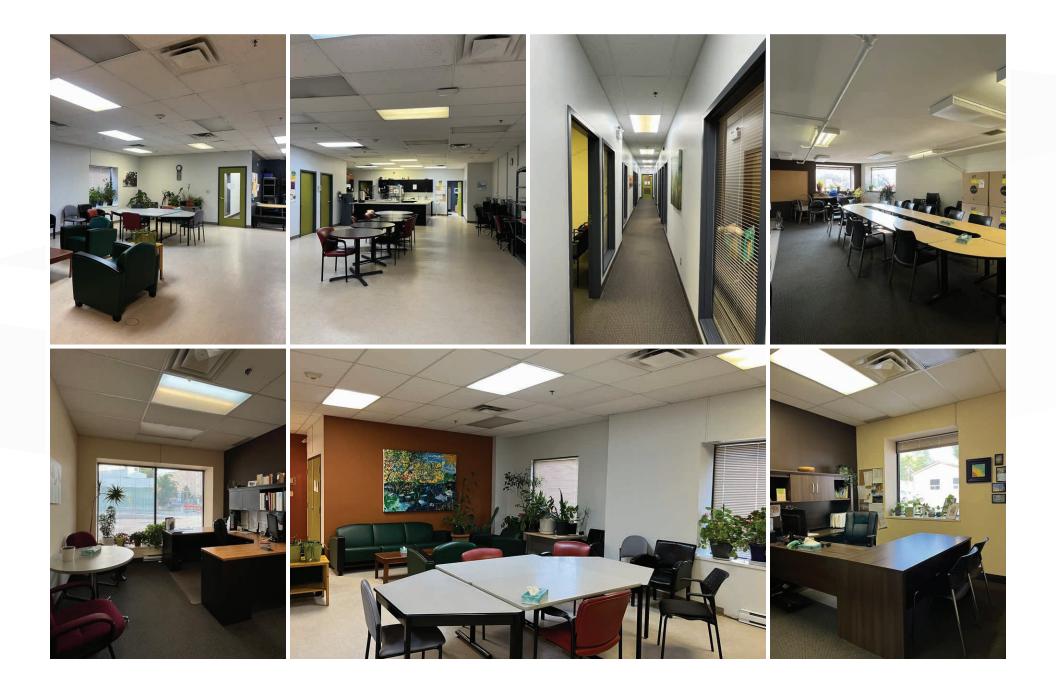




### Floor Plan
